

Memorandum of Understanding

Between

School of Mechanical Engineering, Chonnam National University, Republic of Korea and College of Mechanical and Electrical Engineering, Wenzhou University, P. R. China

School of Mechanical Engineering, Chonnam National University located at 77 Yongbong-ro, Buk-gu, Gwangju, 61186, Republic of Korea, and **College of Mechanical and Electrical Engineering, Wenzhou University** located at Wenzhou City, Zhejiang Prov., 325035, P. R. China, have agreed as follows, recognizing the importance of establishing a close cooperative relationship between the two parties, with a view of promoting cooperation in the fields of the education and the academic researches.

1. Exchange of Students

The students participating in short-term or long-term exchange programs under the terms of the Memorandum shall be selected by the home party, and the host party shall make final decisions in each case. The host party shall accept the mutual agreed number of the exchange research/post-graduate/graduate/undergraduate level students of the guest party.

2. Exchange of Faculty and Staff

The two parties will develop joint programs for short-term or long-term exchanges on education, research and administrative personnel. The number of personnel to be dispatched, the purpose, time, and period of dispatch, and other terms and conditions thereof shall be decided on a case basis after mutual consultation.

3. Budget for Each Specific program

The necessary budget for each specific program and activity that is implemented under the terms of this MOU will be discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity.

4. Maintenance of Secrecy

It is understood that the parties shall not disclose to any third party confidential information of the other party or of mutual activities. Agreements governing the exchange of specific proprietary information will be negotiated and put in place prior to

any such exchange.

5. Effective Period of This Memorandum


The effective period of this agreement shall be ten years starting from the date of signing. In the event one of the parties desires to extend the effective period, it may be extended after mutual consultation and agreement.

6. Interpretation of Terms

In the event doubts should arise in the interpretation of the provisions of this agreement or problems about matters not described therein, both parties shall consult with each other and make every effort to settle any differences amicably in the spirit of this agreement.
